Responsible Participation and Voluntary Account Restriction Policy

PURPOSE

BestLife Trade Academy is committed to promoting responsible participation within its educational ecosystem.

This Self-Exclusion Policy allows users to voluntarily restrict their access to the platform if they believe their participation is becoming excessive, stressful, or negatively impacting their personal life.

The purpose of this policy is to promote:

Responsible education

Healthy participation

Personal accountability

Digital wellness

VOLUNTARY SELF-EXCLUSION

Users may request voluntary self-exclusion at any time.

Self-exclusion may include:

Temporary account suspension

Permanent account closure

Restriction of access to paid services

Restriction of participation features

Requests must be submitted through official support channels.

TYPES OF SELF-EXCLUSION

Users may choose:

Temporary self-exclusion

30 days

60 days

90 days

180 days

During this time:

Account access may be limited
Participation features may be disabled
Promotional access may be restricted

Permanent self-exclusion

Users may request permanent closure.

This action may include:

Account deactivation
Loss of access
Removal from participation programs

This action may be irreversible.

EFFECT OF SELF-EXCLUSION

During self-exclusion:

Users may not:

Create new accounts
Access restricted features
Circumvent restrictions

Attempting to bypass restrictions may result in permanent bans.

MEMBER RESPONSIBILITY

Users acknowledge:

Participation should be responsible
Education should be balanced
Financial decisions must be personal

Users should consider self-exclusion if they:

Feel financial pressure
Feel emotional stress
Lack understanding of risks
Need time away

Responsible participation is encouraged.

PLATFORM RIGHTS

BestLife Trade Academy reserves the right to impose restrictions if:

Suspicious activity detected
Abuse detected
Irresponsible behavior detected
Compliance concerns arise

This is to protect users and the community.

Platform access is voluntarily restricted.
