Financial participation

Violations may result in termination.

6. MARKETING COMPLIANCE

Affiliates must:

Use official information
Communicate accurately
Avoid exaggerated claims
Promote responsibly

Affiliates must not:

Alter official presentations
Create misleading graphics
Use false statistics
Use unauthorized branding

All promotion must reflect the educational nature of the platform.

7. COMMISSIONS AND INCENTIVES

Affiliates may receive participation-based incentives.

These incentives are:

Community participation benefits

Activity-based incentives

They are NOT:

Salary
Investment returns
Profit distributions
